Dear colleagues,

it is our great pleasure to announce a forthcoming event at the Josip Juraj Strossmayer University of Osijek: *EU Child - Osijek Doctoral Conference*, to be held on 16 March 2018.

Jean Monnet Chair on the Cross-border Movement of a Child in EU ("Jean Monnet katedra za prekogranično kretanje djeteta u EU") has been granted by European Commission in the framework of Erasmus + programme to the University of Osijek (reg.no. 575451-EPP-1-2016-1-HR-EPPJMO-CHAIR). Besides number of teaching courses we are gladly engaging in various non-teaching activities, PhD conference being one of them. We would like to extend and deepen research and open a dialogue to PhD students of law/social studies as well as to their supervisors on cross-border movement of a child topics.

We encourage research on cross-border child movement related to:

- private international law of child movement
- EU agenda for Children
- family reunification
- access to justice for children
- child and adjudicating procedure (civil/criminal/administrative)
- criminal aspects of child migrations –abductions / trafficking
- child labour and youth employment
- child protection substantive family law
- children refugees / children migrants
- child and fundamental rights
- child and identity
- children and name / status
- children and successions/ property situated abroad
- relevant ECtHR and CJEU rulings,

list being non-exhaustive. Therefore, any other related topic would be equally taken into consideration.

PhD students are encouraged to take part in the international conference. We invite to deepen and shape a research to respective topics, as well as present it: a) publicly on the conference and b) by preparing a quality scientific paper for publication. We invite PhD candidates to respond to this call, either by presenting an abstract individually or in collaboration to their supervisors. Supervisor to this activity can be any academic holding PhD, which has passed a







scientific-teaching selection. Supervisor may, does not have to be a nominated mentor for the PhD thesis.

Working language of the conference and publication is English.

Abstract should be sent to euchild@pravos.hr by 15 June 2017. Obligatory content of the abstract:

- author's name and surname, academic or professional status
- name and address of the author's place of work or home address, e-mail address
- the title of the paper
- 100-250 words stating the aims, objectives and research methods used
- maximum 6 keywords

Participants whose abstracts are selected for conference would be notified by 1 July 2017.

Full papers should be submitted by 15 September 2017. We invite you to follow the authors guidelines http://www.pravos.unios.hr/pravni-vjesnik/instructions-for-authors and submit a paper fully meeting these requirements.

Review, ethical and other rules as prescribed at http://www.pravos.unios.hr/pravni-vjesnik/the-journal-of-law apply accordingly.

Selected papers would be published in special volume of Pravni vjesnik: Journal of Law and Social Sciences of the Faculty of Law Josip Juraj Strossmayer University of Osijek. It is an open access journal indexed in:
