## 1. UVOD

Anketiranje dolaznih studenata unutar Erasmus+ programa međunarodne mobilnosti provedeno je dva puta, pri čemu je prva anketa (iz 2020. godine) obuhvatila sve dolazne studente koji su posjetili Pravni fakultet Osijek od pristupanja programu pa do akademske godine 2018./2019.; a druga (iz 2021. godine) poslana je studentima koji su u programu sudjelovali nakon tog vremena te koji su prema rasporedu trebali ostvariti ili barem započeti mobilnost u vrijeme anketiranja.

Ankete su izrađene u suradnji Erasmus+ koordinatora, Povjerenstva za kvalitetu te Ureda za kvalitetu, dok je druga anketa prilagođena novonastaloj pandemijskoj situaciji od strane Ureda za kvalitetu, koji je i proveo oba istraživanja.

Nažalost, razne su okolnosti doveli do malog anketnog uzorka – nevelik broj dolaznih međunarodnih mobilnosti, kod prve ankete znatno vremensko razdoblje od prvih mobilnosti je utjecalo na nedostupnost (sada već bivših) studenata, problemi s valjanošću e-mail adresa zabilježenih u dokumentaciji, određeni broj nekvalitetnih unosa, i tako dalje.

Posljedično, u 2 provedene ankete zabilježeno je 5 valjanih i korisnih unosa studenata, a odgovori na anketna pitanja spojeni su gdje je moguće (većina pitanja je identična ili samo s drukčije formuliranim rečenicama), dok su na specifična pitanja iz druge ankete (vezana uz Covid i on-line nastavu) prisutni samo odgovori studenata iz druge ankete.

Odgovori i komentari ispitanika ostavljeni su u izvornom obliku.

## 2. OPĆI PODACI ISPITANIKA

Od pet valjanih unosa u ovim anketama četiri su ispitanika došla iz Španjolske, dok se jedan nije izjasnio.

Svim anketiranim studentima međunarodna mobilnost na Pravnom fakultetu Osijek bilo je prvo sudjelovanje u Erasmus+ programu, ali i prva međunarodna mobilnost općenito, nisu koristili druge programe.

Tri su ispitanika na Pravnom fakultetu Osijek borvila jedan semestar, dok je mobilnost dva ispitanika trajala dva semestra.

### 3. PRAVNI FAKULTET OSIJEK

Ovo poglavlje donosi odgovore ispitanika na pitanja koja su se odnosila na Fakultet – razloge za izbor Fakulteta kao odredišta, pozitivna i negativna iskustva doživljena ovdje te usporedbe sa domicilnom institucijom.

- Agreement with my home university and visit the eastern part of Croatia
- Wanted to live in Croatia. I like "balkan" traditions.
- Because in Spain I study law
- I wanted to go to Croatia and also thought a small city would be the best option
- I wanted to go to the east of Europe and I really liked the idea of going to Croatia, I didn't matter the destinations inside Croatia so the destiny came me up there.

- Very good professor. Very welcoming citizens
- Teachers were very friendly and gave us every facility they had in their power.
- The teachers are so polite and kind
- My experience in the faculty of law was really positive in general, professors made it easy for us to adapt and helped us whenever we needed. I coursed the first semester physically and the second one on-line due to corona but I stayed in Osijek so I was able even to meet the professors physically at the end of the semester to deliver my final essays.
- The city in general, the erasmus people that I met there and related with this my upgrade in English, but in general the peace that the city transmitted to me.

- We lacked of classes in English, which ended up on a more self-learning experience instead of one sharing a table within other students.
- Because of the Covid I've never attended to any face to face class
- The online classes but it wasn't the fault of anyone, the covid situation was complicated and also I couldn't take advantage of my free time as I wanted due to the restrictions.

- Very good professor. Guys from the ESN organization very helpful
- Ability of learning English which wasn't implemented in Spain when I studied. Every facility they gave us as Erasmus students and personal treatment from Rektorat.
- In this faculty dealing with people is much more pleasant
- I think it's an advantage that it is so small that allows a closer attention, the faculty where I come from it's so big that Erasmus students can find it really difficult to adapt. And also the fact that they offer a fair amount of courses in English is very positive.
- I really think the professors were really kind with us, the Erasmus students.

- Maybe the lack of resources if I had to mention one. Although it is obvious you cannot compare almost 10 years ago Osijek with our city with 6x more population.
- Maybe is not that known as other cities in Croacia as Slipt or Zagreb so i would say the publicity of the city.

- Presencial classes, but i think we didn't have due to the epidemiological situations.

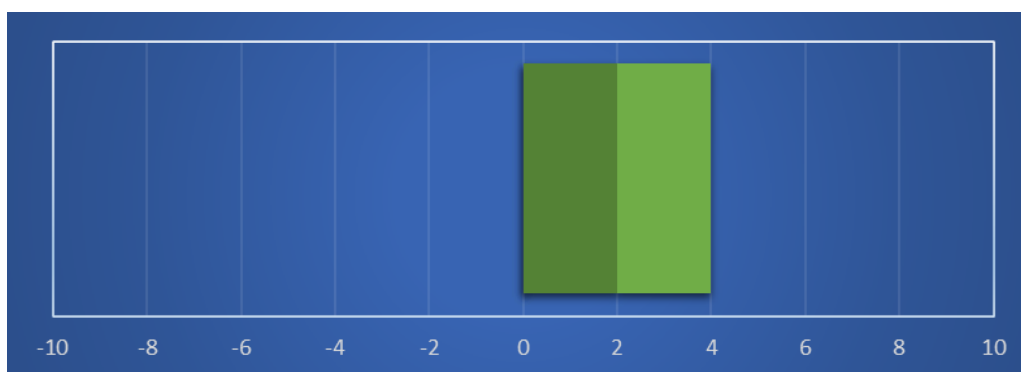
#### 4. BROJČANE OCJENE

Pitanja na koja su ispitanici davali brojčane ocjene obrađena su na način da su odgovori projicirani na grafove Likertove skale, s ocjenama 1 i 2 kao negativnima (s vrijednostima od -2 boda za ocjenu 1 odnosno -1 bod za ocjenu 2), ocjenom 3 kao neutralnom te ocjenama 4 i 5 kao pozitivnima (s vrijednostima od 2 boda za ocjenu 5 i 1 bod za ocjenu 4). Najmanje i najveće moguće vrijednosti ocjena su dakle -10 za pet zabilježenih ocjena 1, odnosno 10 za pet zabilježenih ocjena 5.

U grafovima su zabilježeni odgovori prikazani u negativnom ili pozitivnom dijelu skale, i to označeni nijansama narančaste za negativne odnosno nijansama zelene za pozitivne ocjene. Neutralne ocjene (3) nisu prikazane na grafovima jer ne utječu na konačni balans pozitivnih i negativnih iskustava, kao što ne bi bile prikazane niti ocjene 0 da su bile zabilježene u ovom istraživanju.

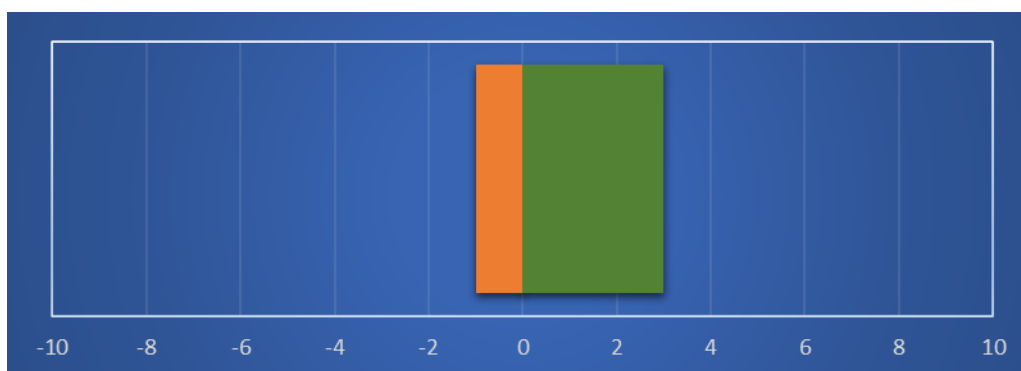

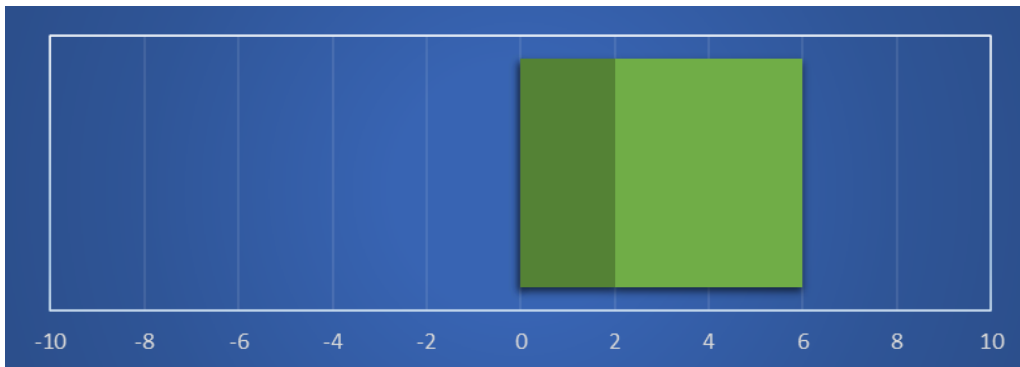
**[Faculty of Law Osijek is perceived as a respectable academic institution]**

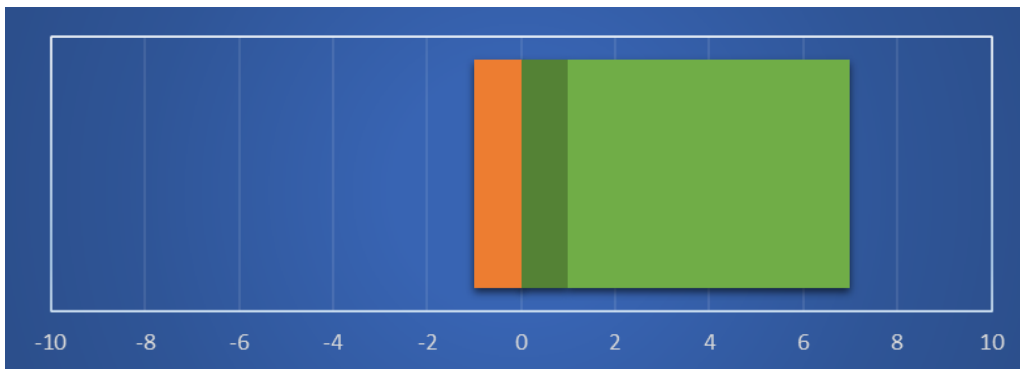
